- Built a system for NFT rarity permutations dividing 8000 NFTs into 6 tiers, allowing us to build and commission our artwork around this mathematical model

- Built a network of hundreds of contacts in Fintech through LinkedIn and networking events- some of which we hosted.
- We developed a system of lending/leasing that allows for individuals to invest in a decentralized ETF which we call a "LeaseToken". Our LeaseToken is now TFSA eligible. The tech stack was React, Node.js and PostgreSQL for our database.
- Raised 250k for our pre-seed round through accredited investors, with over 20 investors who have continued to invest more into the company each year.
- Hit the target of 30% MoM growth- the metric that correlates most with tech-startup survival.
- The company is currently evaluated at 10 million, having grown from an evaluation of 300k at the start of 2021.
